Freedom of Information Act

I am replying to your Freedom of Information request, which the House of Lords Appointments Commission (HOLAC) received on 2nd March 2021.

You asked:

I would like to request the number of applications made to you between the years 2010-2021.

If possible, I would also like a breakdown within each year of age of the applicants, as well as how many applicants were appointed.

On a side note, what is the process after your body decides that someone is eligible for appointment?

The information you have requested is <u>held</u> by the House of Lords Appointments Commission.

The Commission has received 1095 applications between 2010 and 2 March 2021, when your request was received.

I am able to break down applications by age. Figures of five or fewer are not specified. Where a number is very low (less than 5) the information cannot be disclosed as it could potentially identify the individuals involved, especially if combined with other data, and this would constitute a breach of the Data Protection Act 1998.

Therefore, this information is exempt from disclosure under section 40(2) of the Freedom of Information Act 2000 on the grounds that it is personal information.
