FREEDOM OF INFORMATION ACT REQUEST

I am replying to your Freedom of Information request, which the House of Lords Appointments Commission (the Commission) received on 22 June 2022, and further clarified also on 22 June.

You asked:

For each of the years 2010 to 2021, and for 2022 up until April 11, please can you say how many political nominations there have been for life peerages?

For each of the years 2010 to 2021, and for 2022 up until April 11, please can you say how many political nominations (party political) for life peerages the Commision has been notified of/vetted for propriety?

We are writing to advise you that following a search of our paper and electronic records, we have established that the information you requested is partially held by the House of Lords Appointments Commission.

All of the information that you have requested falls within section 37(1)(b) of the Freedom of Information Act, which relates to the conferral of honours and dignities. A peerage is a dignity for the purposes of the Act. Section 37 is a qualified exemption which is subject to a public interest test. In favour of disclosing information, there is a strong public interest in knowing that the appointments process is accountable and transparent, and in maintaining public confidence in the system. In favour of maintaining the exemption, there is a strong public interest in protecting the confidentiality of the consideration of individual nominees. We judge that the balance of public interest favours disclosure of overall figures. To protect the confidentiality of the Commission's discussions and the confidentiality of candidates' personal data -

and in line with standard practice - the Commission is not disclosing annual figures of fewer than five people.

With regards to question 1, we have interpreted 'political nominations' as relating to nominations which were put forward through political means, or in other words, by a political party leader outside of the crossbench application process which the Commission also manages. This includes non-affiliated nominations and Prime Minister's crossbench exception nominations. Information is not held in relation to 2010-2012 and limited information is available for 2012.
